

# RURAL MUNICIPALITY OF SUTTON NO. 103

## BYLAW NO. 2/19

### A PUBLIC UTILITY MANAGEMENT BYLAW RESPECTING DISPOSAL OF HOUSEHOLD WASTE

The Council of the Rural Municipality of Sutton No. 103 in the Province of Saskatchewan enacts as follows:

1. This bylaw may be cited as the “**Garbage Disposal Bylaw**” for the Rural Municipality of Sutton No. 103.

#### 2. DEFINITIONS

In this bylaw:

- a) **Administrator** shall refer to the administrator for the Rural Municipality of Sutton No. 103;
- b) **Customer**
  - i) in the case of an individual resident, one who has agreed to the placement of a garbage disposal bin on their private property by submitting an Application for Loraas Bin Placement;
  - ii) in the case of a resident of either the Hamlet of Mazenod or the Hamlet of Palmer, an occupant of a residence within the Hamlet.
- c) **Municipality** shall refer to the Rural Municipality of Sutton No. 103, including the Hamlets of Mazenod and Palmer;
- d) **Property** shall mean a parcel of land located within the boundaries of the Rural Municipality of Sutton No. 103, on which a building may or may not be situated, whether such buildings are occupied or unoccupied.
- e) **Waste Bin** shall mean the waste disposal bin provided by Loraas Disposal.

#### 3. PURPOSE

The purpose of this bylaw and the schedule attached hereto is to set out fees with respect to the garbage disposal service provided to residents of the Municipality.

#### 4. FEES AND CHARGES


- a) Fees shall be invoiced to the Customer in accordance with Schedule “A” attached hereto.
- b) The annual billing period for services shall extend from January 1 to December 31. Stub periods shall be pro-rated accordingly.
- c) Accounts that remain unpaid thirty (30) days from the day of billing shall be considered in arrears.
- d) A penalty of two percent (2%) per month compounded monthly shall be added to arrears.
- e) Annual charges may be increased, whereupon Customers will be notified before November 30 of the year prior to that in which the increase is to go into effect.
- f) Surcharges will apply if the Customer requests that their bin be emptied more than once every four-weeks as scheduled.
- g) Bins requested after February 28, 2019 will be subject to a delivery charge.
- h) Pursuant to Section 369 of the *Municipalities Act*
  - i) unpaid charges for this waste disposal service may be added as arrears to the tax roll of the property for which the service is provided.
  - ii) costs incurred in the service of notice by registered mail to the owner and or tenant shall be added as arrears to the tax roll of the parcel of land for which the service is provided.

**SCHEDULE "A"**  
**Bylaw No. 9/20**

**FEES**

**Individual Customers:**

3-yard Waste Bin emptied every four (4) weeks ..... \$144.00 per year  
Invoiced annually; stub periods shall be pro-rated.

1 set of keys, when Customer requests a locking bin ..... \$25.00

**Hamlet of Mazenod Customers (Shared Bin):**

6-yard Waste Bin emptied every two (2) weeks ..... \$144.00 per year  
Invoiced annually; stub periods shall be pro-rated.

**Hamlet of Palmer Customers (Shared Bin):**

6-yard Waste Bin emptied every two (2) weeks ..... No Charge

- \* Each Hamlet bin shall be locked, and each household within a hamlet shall be provided with one (1) key, free of charge
